Re: Sanitary Sewer & Water Main and Lateral Replacement & Rehabilitation Project

This letter is to inform you that the water and sewer mains and service laterals will be undergoing either replacement or rehabilitation during 2023 and 2024 throughout the Meadowbrook Development. A. H. Moyer, Inc, is working for East Cocalico Township Authority to complete this work. The work will impact the street and portions of driveways and yards. ECTA has additional information regarding the project on their website and on Facebook.

How will this affect me and my property?

- The work will have a significant impact on the normal flow of traffic during daytime working hours. Portions of the road will be closed in sequence with the work. Access to driveways will be accommodated as much as possible.
- During the replacement of the service laterals- for sewer and water- yards will be excavated, landscaping may be disturbed, driveways may need to be excavated. Restoration (back to pre-construction conditions) to the impacted areas will be completed as part of the project.
- The work is predominantly directed to occur within in the public right-of-way. Some properties may require additional work outside of the right of way.
- Communication and electric utilities may need to be temporarily out of service for contractor safety. Notice for outages will be provided as early as possible.
- When your water service is replaced, the water to your property will be shut off for a time, generally, less than 2 hours. For planned connections, contact with the resident will be made the day prior. If you require additional notice, please communicate directly with the ECTA resident inspector.
