

BUILDING PERMITS

Building per-

mits are required for all construction projects as well as a fence, pond, or

a change in the use of the property. Permits are

not required for sealing driveways, painting, wallpapering, new flooring, sidewalks, swings and replacement of siding or roofs. Please call the Zoning Office at 717-336-1720 if you have any questions.

WINTER STORMS

Please clean your sidewalks within 24 hrs. after a snow/ice storm (Ordinance #2004-02). In addition, throwing, tossing, blowing, or depositing snow/ice onto any public road is prohibited (Ordinance #2006-10). Violators are subject to fines. Your cooperation is very much appreciated.



HOMEOWNER'S ASSOCIATIONS

porches in the development, the Township cannot issue a

permit for you to add a porch.

VEHICLES

No uninspected unregistered vehicle is to be parked on the property other than in an enclosed building. This goes for parts of vehicles, tires, and other "junk".



Recreational vehicles can be parked behind the setback line in side or rear yard, so long as the

unit is set back not less than five (5) feet from any adjoining line and screened from any adjoining property. Recreational vehicles cannot be parked or stored on public roadways.

DOGS



It is unlawful to allow your pet to run at large. All pets must be either on a collar and leash or confined in a

cage or run area, or under reasonable control within the confines of your own property. It is the duty of the pet owner to keep pets secure, under control and quiet.

BEFORE YOU DIG



Whether you're laying the foundation of a building or just planting a tree, you must call to have the underground utility lines located before digging. By calling PA One Call at 811 or 1-800-242 -1776 three working days before you start your project, all mem-

ber facility owners in your work site area will be notified of your plans and will mark their lines in the vicinity. It is the responsibility of the person who is digging to place the call. If you do not call

and the underground utility lines are damaged, then you could be held for all losses and expenses.

The Importance of Stormwater Management?


WE ARE ALL CONNECTED

Did you know that agriculture and urban/suburban water runoff represents the largest man-made sources of nitrogen in our water?

Currently, Pennsylvania is not on pace to meet its 2017 or 2025 goals for nitrogen in the water by having necessary practices in place. The Commonwealth must reduce 23 million pounds of nitrogen to meet the 2017 outcomes; and East Cocalico Township is working to achieve full compliance with Pennsylvania's Manure Management Program and Agriculture Erosion and Sediment Control programs, which apply to 80-90% of the animal operations in Pennsylvania's portion of the Chesapeak Bay watershed.

East Cocalico Township is helping combat this problem by (1) educating the public through meetings, (2) educating our local farmers, (3) informative documents, and (4) a website chocked full of material (www.eastcocalicotownship.com). Stormwater Management / Riparian Buffers

The Township adopted the "East Cocalico Stormwater Management and Earth Disturbance Ordinance" to support the Township's on-going goals of properly managing runoff and improving water quality. The general purpose of the Ordinance is to control and minimize stormwater runoff impacts resulting from development. The ordinance requires stormwater runoff from new land development to be infiltrated and detained on-site in an effort to replenish groundwater aquifers, improve water quality, maintain natural stream conditions, preserve riparian buffer areas, and regulate the peak stormwater discharges from the development site. With limited exceptions, the Ordinance applies to all residential, commercial, and industrial development, including homes, barns, and home additions.

It is very important to maintain the riparian buffer zones in the Township, as they act as filters to all creeks and streams. Healthy forest buffers feed streams with organic matter, which in turn rejuvenates the stream. There is three to five times more biological activity in a stream with a healthy forest buffer. The goal is to reduce sediment, phosphorous, and nitrogen content in streams. The creeks and streams are the capillaries to our watershed. Riparian is defined as pertaining to a stream, river or other watercourse and also plant communities occurring in association with any spring, lake, river, stream, or creek, through which water flow at least periodically. A Riparian Buffer is defined as a best management practice that is an area of permanent vegetation along a water course.

While potential stormwater impacts from large scale developments are obvious to most people, the cumulative impacts from small projects such as newly constructed single-family homes, barns, or home additions may not be as obvious. These small scale projects can create significant problems to adjacent or downstream properties.

CARDBOARD DUMPSTER: Corrugated cardboard only; please no paper-board products similar to cereal boxes, shoe boxes and tissue boxes. Located behind the Township Municipal Building, 100 Hill Rd., Denver. Open M-F, 8am-4:30pm; Sat., 8am-3pm. No Sundays/Holidays.

PAPER DUMPSTER: Paper accepted is newspapers, phone books, books (tear off any hard binding), catalogs, magazines, computer paper, junk mail, manila folders, stationary, carbonless paper, office paper, etc. No clips, paperclips, strings or plastic bags. Located behind the Township Municipal Building, 100 Hill Rd., Denver. Open M-F, 8am-4:30pm; Sat., 8am-3pm. No Sundays/Holidays.

PICK UP AT THE TOWNSHIP:

(1) Kraft Bags for your leaves (contact your trash hauler for the pickup days and costs), (2) recycling bins and buckets, and (3) battery bags for your used batteries. When the bag is full, please place it beside your recycling bin on your normal trash pickup day.

DROP OFF AT THE TOWNSHIP:

Used cell phones, batteries, and chargers that are no longer needed, and (2) CFL light bulbs (the small "spiral" bulbs) are collected at the Township lobby area, 100 Hill Road, Denver, M-F, 8am-4:30pm). Sorry we do not accept the long CFL/balusters/tubes at the Township. Please call your hauler or transport them to Lancaster County Solid Waste Authority (LCSWMA), please call LCSWMA for more information 717-397-9968.

WOODY WASTE SITE: A

site designated for the residents of East Cocalico for trees and/or tree branches. No commercial dumping. Accepted are limbs and stumps less than 12" in diameter. No leaves, grass, furniture, bricks, treated wood, sod, green plants, flowers, mulch, pine needles, or any other trash of this nature. LOCATING AND OPERATING YOUR WATER SHUT-OFF VALVE

probably You know where and how to turnoff or reset the electric breaker in your house or replace a fuse. Do you also know where your shut-off main water valve is located and how to operate it? home has a shut-off valve located inside the house. Typically the shut-off valve is located near where the water service enters the home, usually close to the water meter. It is a good idea to identify or mark this valve and to close and reopen it once a

year to ensure it is operating properly. It may also be a good idea to show this valve to any of your children you feel are responsible enough to operate the valve in your absence. In case of a water leak or other water-related problem. this is the valve to close in order to shut off the municipal water supply entering your home. If you need help locating your shut-off valve or you suspect it is not operating properly, please call a plumber of your choice for assistance.

COLD Weather reminder

Are you ready for cold weather? The East

Cocalico Township Authority wants to remind you to winterize your home or business. Make sure that any outside taps or hose connections are turned off and drained and not vulnerable to freezing. Please attend to any pipes that are in unheated areas of your home or business. Pipes can freeze and burst if not properly insulated causing a great deal of damage and a large water bill. Also if you live near a fire hydrant, the Authority would like to encourage you to keep those



hydrants accessible by removing any accumulated snow that may block or hide them. If possible, snow should be removed a minimum of three feet completely around the hydrant to provide the fire company with unobstructed access. Your neighborhood and fire company will benefit from hydrants that are readily visible and easily accessible.

While we're on the topic of cold weather, this is normally the time of year the Authority experiences more breaks in our water lines. Our public works staff makes every effort to keep our lines in good repair in order to provide you with uninterrupted service. However, repeated freezing and thawing cycles will sometimes cause the ground around the pipes to shift resulting in breaks and loss of service. If you see water coming to the surface or standing in the street or experience a sudden decrease of water pressure at your home or business, please report it to us as soon as possible. Calls to report leaks can be made to the Authority 24 hours a day, 7 days a week at (717) 336-1731.
